NOTIFICATION

No./556/Samnvy/2024.— In exercise of the powers conferred by sub-section (1) and (4) of Section 28 of the Chhattisgarh Madhyamik Shiksha Adhiniyam, 1965 (No. 23 of 1965), the Board of Secondary Education, Chhattisgarh, hereby, makes the following further amendment in the Board of Secondary Education Chhattisgarh Regulation, 1965, these regulation have been approved by the State Government, namely:-

AMENDMENT

In the said regulation,-

1. Under Chapter XIX, for the heading “Supplementary Examination”, the heading “Supplementary Examination or Second Main Examination” shall be substituted.
2. After regulation 148, the following regulation shall be inserted, namely:-

“148A. Second Main Examination.-

- (1) Chhattisgarh Board of Secondary Education will conduct the annual examination of high school (Class 10th) and higher secondary (Class 12th) twice in one academic session. The first examination will be addressed as First Main Examination and the second examination will be addressed as Second Main Examination.
- (2) It will be mandatory to fill the application form to appear in the second main examination and only those students, who are registered in the first examination will be able to fill the application and they will have to fill the online examination application from the same institution in which, he had filled the application for the first main examination.
- (3) A separate date will be fixed by the Board of Secondary Education for filling the application form for the second main examination.

- (4) Candidates, whose result in the first main examination has been in the supplementary category, it will be mandatory for those candidates to apply in all the subjects given supplementary and candidates can also apply for improvement in marks in other subjects.
- (5) Candidates, who have failed or remained absent in the first main examination can apply for the second main examination. In such situation, it will be mandatory for them to apply in all the absent/failed subjects and the candidates can also apply for improvement in marks in other subjects.
- (6) If, the result of the candidate is pass in the first main examination and he is not satisfied with his marks, then he can fill-up the examination application for improvement of marks in the second main examination. It is not necessary that the candidate should apply in all the passed subjects, the candidate can apply in one passed subject or two passed subjects or more passed subjects as per his wish. The result will be prepared considering the increased marks in the subject/subjects in which the candidate improves his/her marks in the second main examination and the marks obtained in the first main examination in other subjects.

If the candidate is not able to improve the marks in the subject/subjects in the second main examination, then in that situation only the marks of the candidate in the first main examination will be considered and the marks sheet will not be issued to him again.

- (7) The candidate will be eligible to appear in the same subjects in the second main examination in which he has filled the examination application form in the first main examination. Under no circumstances, he can change his subjects in the second main examination. It is also worth mentioning here that if the candidate has taken an additional subject in the first main examination, then he can appear in the second main examination also by taking the same subject as an additional subject.
- (8) While preparing the results of the candidates in the second main examination, the marks obtained in the practical and project in the first main examination will be considered for the second main examination, but if any candidate is not able to appear in the practical and project examination or fails in the first main examination, then such candidates will be eligible to appear in the practical and project examination in the second main examination.
- (9) The same grace marking policy will be valid in the second main examination, which is valid in the first main examination.
- (10) If the candidate is eligible for bonus marks in the first main examination, then he will be eligible for bonus marks in the second main examination also but the bonus marks will not be repeated i.e. after deducting the bonus marks added in the first main examination, the bonus in the second main examination will be added.
- (11) After the result of the first main examination, a temporary merit list will be issued and after re-calculation/re-evaluation of the first main examination, a permanent merit list will be issued.
- (12) The passed candidate shall be issued mark sheet in first main examination and if the marks increased in second main examination to the candidates, then such circumstances, shall get first examination mark sheet from the students, second main examination marksheet shall be provided.
- (13) Counterfoil of mark list and result of recount/re-evaluation of 2nd TR, 2nd Main Examination will be printed only after their release but the database of both the exams will be kept safe. In the mark list of the first and second main examination, the name of the studying institution for regular candidates and the name of the forwarding institution for self-study candidates will be mentioned against the name of the institution/centre.
- (14) While printing the mark list of the second main examination. special mark (exa.\$) will be marked in the those subjects, in which the marks of the candidate have increased.
- (15) After declaring the results of the first main examination, the second main examination will be started from the third week of June. since the results of retotaling/revaluation of the first main examination cannot be declared before the commencement of the second main examination, therefore, candidates will have to fill the application for Second Main Examination without waiting for the result of retotaling/revaluation of First Main Examination. If the results of retotaling /re-evaluation of the first main examination are

declared after the commencement of the second main examination, then any representation or complaint of the candidate will not be considered.

- (16) Those candidates who appear in the second main examination for improvement of marks in the subject/subjects and improve the marks or there is no improvement in the marks, then such candidates are eligible for division improvement as per the provisions of the previous rules on the basis of eligibility.
- (17) Those candidates who remain unsuccessful in some subjects even after the second main examination, will get the benefit of third and fourth chance as per the current rules in the first main examination and second main examination of the coming year.
- (18) Like the first main examination, in the second main examination also, question papers will be printed in three sets (A, B, C) in main subjects and single set in minor subjects.
- (19) It will be mandatory for the candidates, who want to appear in the examination under these regulations, to deposit the fees prescribed by the Board.”
